In ground (Vinyl)	\$0.50 per sq. ft.* (\$100.00 minimum fee)
In ground (Concrete)	\$0.55 per sq. ft.* (\$100.00 minimum fee)

Above 24.99kw - roof or ground mounted	\$500.00 plus \$15.00 per \$1000 of installation cost*

Fire Inspections	\$125.00/\$250.00 per facility plus \$50.00/\$75.00 per unit (Owner occupied/ Non-Owner Occupied)
<u>Portable Storage & Moving Units</u>	
Flat fee for each 30 days, up to the maximum allowable period of use	\$75.00/\$200.00
If permit expires without renewal -	\$105.00/\$250.00
<i>(The maximum allowable period of use is 180 days per year if a construction permit is also in effect; 60 days if no construction permit is in effect.)</i>	
<u>Sign Permit Fees</u>	
Any permitted size sign	\$75.00 plus \$0.50 per sq. ft. (\$75.00 minimum per sign) *
<u>Operating Permits</u>	
Annual for All Assembly as per Title 19 Part 1203	\$150.00
<u>Certificates</u> (are required for ALL permitted work)	
Certificate of Occupancy, Use or Compliance	\$50.00
<u>C/O Searches</u>	
Per section/block/lot	\$200.00
<u>Old Permit Close Out Fee</u>	
All permits that have not been closed out in the original permit time frame. (1 year or less, unless extended)	\$150.00 or more*
<u>Failure to obtain required permit/s prior to commencement of work</u>	
Major construction permit (\$3,000.00 value or more)	\$1,000.00 flat fee plus all original permit fees
Minor work permit (0-\$2000 & \$2000-\$3000)	\$100.00/\$200.00 flat fee plus all original permit fees
Build out of basements/garages/barns	\$1,500.00 plus double the fees of the original permit
Site work without site plan approval	\$5,000.00 per occurrence
